

USE OF THE FSC® LABELS AND TRADEMARKS

The company may use the FSC® trademarks as soon as the certificate is issued and the company is registered in the FSC database. All use of the FSC trademarks (label and words FSC® and Forest Stewardship Council®) shall be in compliance with the relevant FSC standards and approved by DNV GL.

1 REQUEST FOR ACCESS

FSC provides a tool where the labels are to be created. The FSC will charge EUR 50 when you get access to the tool. Therefore, the access is not given automatically; you will need to request access to the FSC labelling system. The request is e-mailed to fscapproval@dnvgl.com. (This information is also in the letter that is sent together with the certificate).

The access is given in the FSC database, and it is not technically possible to grant access before the certificate is issued.

2 READ THE STANDARD

Please, study the standard FSC-STD-50-001 Requirements for use of the FSC trademarks by certificate holders prior to you request for approval. The standard can be found on www.fsc.org. Click: Resources, Documents, Certification documents and then Standards.

3 ASK FOR APPROVAL

As a certificate holder you need approval from DNV GL before using the FSC trademark, both for on- and off product use. A request for approval can be e-mailed to fscapproval@dnvgl.com. We will then review the intended use according to the standards for using the FSC trademark. You may start using the FSC trademark as soon as we have sent the approval (by e-mail).

Please, include the following information in your e-mail to fscapproval@dnvgl.com:

- Your company name and certificate code.
- Information about the product, what it is, and the material it is made of.
- If it is a packaging, what kind of product will it contain? (Printers should for example provide information about the paper. All

pages from cover to cover need to be made from FSC paper).

- The certificate code of relevant suppliers.
- Enclose a picture or pdf showing how the FSC label will be applied on the product.
- Any text or statements regarding the FSC or responsible forestry should be translated/explained in English.
- For promotional use or use of FSC trademark on web-page or in printed information, please include a picture, printscreen or pdf of your promotional material.

The approval process

The request for approval will be handled within three working days, Monday to Friday. It is recommended to plan for 7 days for the entire approval process since we, in some cases, are required to ask for additional information or changes to be made.
